

# Data Protection Information and Informed Consent

## (Regional Workshops Participants)

**General information:** YouthDecide 2040 is a European project funded by the European Union under the Horizon Europe Programme (Grant Agreement No. 101177438). The project aims to **imagine and build desirable futures for democracy in the European Union by 2040**, placing young people's experiences, values and expectations at the centre.

To this end, the project organises participatory activities—such as national workshops, online consultations and transnational gatherings—in which young people from different countries take part, together with other social and institutional actors.

### The participatory workshops

These **workshops** were part of the project's **Regional Assemblies** which **took place in June-July 2025 and September 2025**. The workshops aim was to create a safe and participatory space where young people could:

- share experiences and viewpoints about democracy;
- collectively reflect on how they would like democracy to work in the future;
- contribute ideas and proposals that will feed later project phases, including National Workshops and the Transnational Assembly with participants from different countries.

Participation was voluntary. No prior knowledge or specific experience was required.

### Who organises the project and processes personal data

**YouthDecide 2040 is coordinated by AIT Austrian Institute of Technology GmbH (AIT)**, based in Austria, and implemented by a consortium of organisations from different countries. Certain consortium partners may process personal data only when this is permissible under data protection law and strictly necessary for the implementation, analysis and reporting of the project. For the regional workshops, Fraunhofer-Gesellschaft zur Förderung der angewandten Forschung e.V. (Fraunhofer) uses the *Microsoft Forms* tool to run anonymous surveys on GDPR compliant infrastructure (see the Tools section. WeDo Project Intelligence Made Easy, S.L. (WeDo), in Spain, acts as the operational contact point and supports the management of data collection and storage in Smartsheet (Europe). In addition, access to data is limited to what is strictly necessary and is

managed by roles (least privilege). Details of the consortium entities that may access data and the relevant privacy contacts are provided in the Annex.

### What data do we collect and why do we use them?

The data you provided during the registration process for the workshop is **stored in a Smartsheet Europe project repository, managed operationally by WeDo**. The personal data collected is used for the following purposes:

#### 1. Data for workshop organisation

Your name and surname, contact details and basic information **are used exclusively to manage your participation**, including travel and accommodation arrangements (if applicable) and **communications related to the workshop and subsequent communications related to the Project**.

#### 2. Contributions and opinions during the workshop

The ideas, reflections and opinions you shared during the workshop are used to:

- a) analyse young people's views on the future of European democracy;
- b) produce project reports;
- c) contribute to publications and dissemination materials.

Whenever possible, these data will be processed in aggregated and/or pseudonymised form so that you cannot be personally identified.

#### 3. Images, audio and creative materials

During the workshop, we collect:

- photographs and/or video recordings;
- audio recordings;
- creative materials produced in groups (texts, drawings, collages or similar).

These materials may be used to:

- a) document the project;
- b) communicate its activities and results via project websites, social media and other project channels.

Your person will never be publicly linked to these data unless you explicitly authorise it.

#### 4. Responses to anonymous questions

During the workshop, we asked short questions by scanning QR codes to collect responses in real time. Responses were collected using *Microsoft Forms*, which is operated on Fraunhofer's own servers (Germany), and were analyzed exclusively in aggregate form. The tool does not store IP addresses or location data. Therefore, the results do not allow conclusions to be drawn about

individual participants. We therefore expressly asked you not to include any personal information in your open-ended responses. If this happened accidentally, it was deleted before analysis.

### What your data will NOT be used for

- Commercial purposes.
- Automated decision-making.

### What tools will we use and where is the data stored?

- **Smartsheet (Europe):** used to manage workshop registration and logistics, with strict access restrictions. The project repository is located in Smartsheet Europe and is managed operationally by WeDo (license holder).
- **Microsoft Forms:** used during the workshop for anonymous QR questions. It is operated on Fraunhofer's own IT infrastructure in Germany. No IP addresses or location data are stored.

### Data retention and sharing

#### How long do we keep your data?

Your personal data **will be kept only for as long as necessary** to achieve the objectives of YouthDecide 2040 and to comply with related legal obligations. Specifically:

- Identifying data will be kept for the duration of the project activities and its reporting/justification period to the European Commission.
- At most, your data will be kept until five years after the end of the final reporting period, and in any case no later than June 2033.
- After this period, data will be deleted or anonymised using appropriate security measures.

#### Who do we share your data with?

Your data **will not be made public or shared with third parties outside the project** unless you explicitly authorised it. It will only be communicated to certain partner entities of the YouthDecide 2040 project when this is permissible under data protection law and strictly necessary **for the development of the project, research and accountability to the European Commission**. The partner entities of the YouthDecide 2040 project are **listed in the Annex**. In all cases:

- Data processing will be carried out in accordance with the General Data Protection Regulation (GDPR).
- The use of anonymised or pseudonymised data will be prioritised wherever possible.
- Data will only be transferred to third countries under the conditions provided for in data protection law.

Details of consortium entities with access to data and privacy contacts are listed in the Annex.

## Your rights and how to exercise them

In accordance with current data protection regulations, you have the right to:

- Access the personal data we hold about you.
- Rectify any data that is inaccurate or incomplete.
- Request the deletion of your data when it is no longer necessary for the purposes of the project, within legal limits.
- Limit or object to the processing of your data in certain cases.
- Request the portability of your data, where applicable.
- Withdraw your consent at any time, without this affecting the lawfulness of the processing carried out previously.
- Lodge a complaint for infringement of rights with the respective national authority.

### Participation in the project is voluntary.

You can stop participating in the project at any time, without having to give any explanation and without this causing you any harm.

Withdrawal of consent applies only to data processing based on consent (e.g., image/video, podcast/public use of audio, and subsequent communications), without affecting the lawfulness of the processing carried out before the withdrawal.
