YouthDecide 2040 – Regional Workshops

YouthDecide 2040 is a European project funded by the European Union under the Horizon Europe Programme (Grant Agreement No. 101177438). The project explores how young people imagine the future of democracy in the European Union in 2040. To this end, the project organises different participatory activities – such as regional and national workshops, online consultations and transnational gatherings – in which young people from different countries participate, as well as other social and institutional actors.

Although we could not include you in the Regional Workshop, we would be very happy to keep you informed about the YouthDecide 2040 project and to invite you to future activities (for example, the upcoming online consultation and other engagement opportunities).

YouthDecide 2040 is coordinated by AIT Austrian Institute of Technology GmbH, based in Austria, and delivered by a consortium of organisations from different countries. **WeDo is the data controller for the personal data of individuals who applied to participate in our workshops** (more detailed information on all institutions can be found in the Annex).

During the workshop registration process, you provided personal data via a specific Smartsheet Europe form. This included sensitive personal data, such as political opinions and values, collected to understand the diversity of profiles among people interested in participating, as well as identifying personal data (for example, age, gender and nationality).

All data were used to classify registered individuals into different participation profiles (for example, “critical”, “apathetic” or “enthusiastic”) through a semi-automated characterisation algorithm. The results were subsequently reviewed by the project’s human team. This characterisation process had no legal effects and did not produce automated decisions with individual impact on registered persons.

What data do we collect and for what purposes?

The data you provided during the application process for this workshop is stored in a Smartsheet Europe project repository, managed operationally by WeDo (licence holder.) The personal data collected is used for the following purposes:

Data for Follow-up communications

Your name and surname, contact details (email) and basic information are used exclusively for communications related to the Project, such as project results, publications or other participation opportunities related to YouthDecide 2040.

Statistical, research, or analytical purposes

Your data may be used for statistical, research, or analytical purposes within the framework of the project. Such purposes may include analysing youth participation profiles, producing aggregated results, and contributing to project reports, publications, and policy recommendations. In these cases, only aggregated and/or fully anonymised data will be used. No individual participant will be identifiable in any publication, report, or dissemination material.

What your data will NOT be used for

- Commercial purposes.
- Automated decision-making.

What tools will we use and where is the data stored?

- Smartsheet (Europe) with strict access restrictions. The project repository is located in Smartsheet Europe and is managed operationally by WeDo (license holder).

Data retention and sharing

How long do we keep your data?

We will keep your contact details until the end of the YouthDecide 2040 project and its reporting period, and at most until June 2033, or until you withdraw your consent, whichever occurs first. If you withdraw your consent, your contact details will be deleted from our contact list.

Who do we share your data with?

Your contact details will be stored in a secure project contact list and may be accessed only by YouthDecide 2040 partners responsible for organising outreach and engagement activities. Your data will not be shared with organisations outside the YouthDecide 2040 consortium, unless required by law and subject to data protection law.

In all cases:

- Data processing will be carried out in accordance with the General Data Protection Regulation (GDPR).
- The use of anonymised or pseudonymised data will be prioritised wherever possible.
- Data will only be transferred to third countries under the conditions provided for in data protection law.

Your rights and how to exercise them

If you believe that the processing of your personal data does not comply with applicable data protection legislation, you have the right to lodge a complaint with the competent national supervisory authority in Federal Commissioner for data protection and freedom of information (www.bfdi.bund.de)

In accordance with current data protection regulations, you have the right to:

- Access the personal data we hold about you.
- Rectify any data that is inaccurate or incomplete.
- Request the deletion of your data when it is no longer necessary for the purposes of the project, within legal limits.
- Limit or object to the processing of your data in certain cases.
- Request the portability of your data, where applicable.
- Withdraw your consent at any time, without this affecting the lawfulness of the processing carried out previously.
- Lodge a complaint with the respective national authority.

Remaining informed about the project is voluntary. You may withdraw your consent at any time, without providing any reason and without any negative consequences. The withdrawal of consent shall not affect the lawfulness of processing carried out prior to its withdrawal.

Legal basis

If you agree, we will process your contact details on the basis of your consent (Article 6(1)(a) GDPR). You can withdraw your consent at any time, without giving a reason and without any negative consequences for you.
